

# A Letter To The Attorney General Of The Province Of Quebec, On The Administration Of Justice

Attorney General Gerretson:

Application is made in accordance with Commissions received for an initial and minimum two days in Court outlining the preliminary case for recoveries by the Crown in Canada of some \$7.3 billions. Toronto, Ontario or Gatineau, Quebec are suggested venues. Ottawa appears ineligible or disqualified, unless an agreed jurist is appointed from elsewhere, as has earlier been requested and accomplished by Ottawa Court Master and/or staff.

Supporting evidence \* should be found on your files because I earlier made similar application to your predecessors, i.e.:

Attorney General Hon. Michael Bryant. He preferred to remove Ottawa Councillor/Police Board Chair Herb Kreling from office, quite improperly replacing criminal charges with an appointment as Justice of the Peace, and so leaving false Ottawa Police Board/Commission minutes as a public record.

Attorney General Hon Chris Bentley: He and/or presumably Premier McGuinty preferred to remove Michael Bryant from Ontario cabinet to an undeserved Toronto sinecure (since vacated) instead of criminal charges.

Both Ministers so left (both concealed and undisturbed) misapplications \* of public funds within public spending including the education purses.

Thirty (or more) days prior to your appointed date and place, I undertake to supply to the appointed Court, and his/her Clerk:

- 1: Some thirty supporting documents with supporting evidence\* of fact unchallenged since 1961 (supplement by a Canadian bank awaited). In 1963, the late Chief Justice J.T. Thorson instructed me to "assemble fact, fact, fact and remove emotion" (my family was then endangered), and I and others \* have so endeavored.
- 2: An initial list (enabling Summons) of some six to sixteen witnesses (who may or may not later become either Witness for the Crown or a Defendant).

Those matters to be supplemented by prima facie evidence of illegal insider stock trading, which currently awaits data supplement requested from a Canadian bank.
